

# SUMMARY ANNUAL REPORT for J.M. Huber Corporation Employee Benefit Plan

This is a summary of the annual report of the J.M. Huber Corporation Employee Benefit Plan, Employer Identification Number 13-0860350, Plan Number 501, for plan year January 1, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## Uninsured Components

J.M. Huber Corporation has committed itself to pay certain medical claims and all flexible spending account expenses incurred under the terms of the plan.

## Insurance Information

The plan has contracts with Aetna Life Insurance Company to pay certain health, dental and vision claims, Fidelity Security Life Insurance Company to pay certain vision claims, National Union Fire Insurance Company of Pittsburgh, PA to pay business travel accident claims, Prudential Insurance Company of America to pay certain life insurance claims, Lincoln National Life Insurance Company to pay life insurance, accidental death and dismemberment, long-term disability and short-term disability claims, ReliaStar Life Insurance Company to pay accident, critical illness and hospital confinement claims, Cigna Health and Life Insurance Company and affiliates to pay certain dental claims and Metropolitan General Insurance Company to pay legal services claims incurred under the terms of the plan. The total amount of premium paid for the plan year ending December 31, 2024 was \$4,885,056.

Because the Prudential Insurance Company of America policy #80751-04-22 is a so-called "experience-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premium paid for the plan year ending December 31, 2024, the premium paid under this "experience-rated" contract was \$49,935 and the total of all benefit claims paid under this contract during the plan year was \$5,000.
